MENTAL HEALTH & RECOVERY SERVICES

We provide services to individuals, couples, and families. These include:

- Crisis Intervention/Linkage and Follow-up
- Mental Health Counseling
- Couple and Family Therapy
- Services for Children and Adolescents
- Psychiatric Evaluation and Treatment
- Psychological Testing
- Group Therapy

SUBSTANCE USE RECOVERY SERVICES

We provide adult and adolescent counseling and support services to individuals who are struggling with alcohol and/or other drug abuse. Services include:

- Substance Use Prevention Education
- Substance Use Assessments
- Individual and Family Counseling
- Inpatient Placement/Referrals
- Intoxicated Driver Treatment
- Group Therapy

CRISIS INTERVENTION SERVICES

We provide crisis intervention services for Sauk County residents, including a 24-hour Crisis Line. The Crisis Line is supported by on-call professionals who are well-trained in crisis intervention. **Crisis Line: (800) 533-5692**

MEDICATION ASSISTED TREATMENT (MAT) SERVICES
